### Case Study: 1, Contoso, Ltd (Case Study B) Background

You are the system administrator for a manufacturing company named Contoso, Ltd. The company has offices in Chicago, Seattle, and Dallas.

Contoso's sales department is located in Chicago. The U department is located in Seattle. The sales and IT departments use Microsoft Exchange Online, SharePoint Online, and OneDrive for Business. All employees in the sales department are in a group named Sales-Users. Employee user accounts are added and removed manually to this group as needed.

Your Active Directory Domain Services (AD DS) domain is named conto50.com. The domain is synchronized with Contoso s Office 365 tenant using Microsoft Azure Active Directory (Azure AD) Connect.

Contoso purchases a toy manufacturer named Tailspin Toys. All employees are located in Dallas.

Tailspin Toys has an on-premises Exchange Server 2016 for all email in the tailspintoys.com domain. There are plans to migrate the users to Exchange Online.

### **Business Requirements**

Email Security: You need to ensure email security meets the following requirements

- · Sales users can easily Identify email messages as internal only.
- Sensitive emails can not be forwarded externally.
- · Sensitive emails can not be sent to external recipients

Licenses: You need to be able to identify which Tailspin Toys users are licensed. Support Contracts: Your company does not currently have any Microsoft support contracts.

Skype for Business pilot: You have recently purchased Skype for Business Online licenses and you plan to pilot the service with IT users. You also want to start utilizing dynamic groups for licensing You have a dynamic group called FS-Users that contains all users in The FT department.

### **Technical Requirements:**

Single Sign-On (SSO): You have the following requirements tor SSO:

• Ensure that users receive a phone call or text message as a second form of

authentication when accessing Office 365 or on-premises resources.

- "he domain for federation must be fs.contoso.com.
- "he solution must support extranet users.
- "he solution must use Windows Integrated Authentication. » The solution must support device registration.
- The solution must be highly availability.
- The solution must be secured as much as possible.

Servers: Vou deploy Active Directory Federation Services (AD FS) and Web Application Proxy (WAP) services using Windows Server 2016. You deploy System Center Configuration Manager (SCCM) and System Center

Operations Manager (SCOM) in the contoso.com domain.

Monitoring: You need to be able to monitor and identify issues in the Office 365 environment.

Pilot: You plan to use a group of 25 Tailspin Toys users to test the functionality of Exchange Online. If the pilot is successful, you must migrate all other users to Exchange Online.

Tailspin Toys users must meet the following requirements:

- Must not exist in an on-premises Active Directory.
- The usernames must be unique.
- Display names can be unique.
- The tenants for tailspintoys.com and contoso.com must be separate.
- Passwords must expire after 365 days.
- Must receive a notification 14 days before passwords expire.



### Case Study: 2, Fabrikam, Inc (Case B)

Fabrikam is a manufacturing company. You manage an on-premises Microsoft Exchange Server environment as well as an Exchange Online environment that is se: up as a hybrid environment for the Fabnkam.com and devfabrikamxom domains. The company recently merged with lailSpin Toys. They have also bought another company named Contoso Ltd. There are no plans to merge with Contoso Ltd. as that company s resources will remain separate from Fabrikam. Inc.

### Domains

Fabrikam, Inc. has two separate Active Directory Domain Services (AD DS) domains. The domain named fabrikam.com is used for production. The domain named devfabfikam.com is used for development only. TailSpin Toys has an AD DS domain named tdilspmtoys.com. Contoso Ltd. has an AD DS domain twined contoso.com.

The development environment is used to deploy new features that are being tested for implementation in the production environment. No features can be deployed into production until they ha<je been fully tested in the development environment. There is a "hird-party multi-factor authentication \MFA) solution that is currently deployed for on premises sign ins in the dovfabfikam.com domain. You are investigating different single sign on(SSO) options including Active Directory Federations Services (AD FS) for the devfabrikam.com domain.

Fabrikara Inc. is completing its merger with TailSpin Toys and is decommissioning the lailspintoys.com namespace and moving those users lo fabnkam.com.

Fabrikam has Microsoft Azure Active Directory (Azure AD) Connect configured and has integrated both the fabrikam.com and devfabrikam.com domains with Office 365. SSO is configured for both the fabrikam.com and devtabrikam.com domains.

#### Office 365

The Office 365 environment must meet the following requirements:

- SSO most be used for all Office 365 authentication in production and development environments for all domains.
- Sign in time restrictions must be enabled for all contoso.com users in the Office 365 environment.
- Exchange Online must be used for all production employee mailboxes.
- The on premises contoso.com domain must be integrated with Office 365.
- Contoso.com must be used for the primary namespace in Office 365 for Contoso Ltd. employees.

#### Infrastructure

The server infrastructure must meet the following requirements:

Production environment

• All now applications that require relational database support must use Microsoft SQL Server ?016.

- All new projects must minimize the number of servers required.
- All new projects must minimize the complexity of the design and topology of the server infrastructure.
- · All externally facing servers must be deployed in a perimeter network-

• All new server deployments should be redundant when possible.

Development environment

- The development environment must support workplace join.
- On premises MFA must be used for all development accounts.

#### lssues

Users report that they receive many unwanted emails. You need to a create a list of the users that receive the most unwanted emails, and a list of the senders of these emails. This report information needs to be automatically collected daily. Users also report the following issues:

• The mailbox named Test.Userl@tievfabrikam.com is hosted in the on-premises Exchange Servers. This user is not able to view free/busy for Test.User2@cievfabrikam.com. Test User1 has issues viewing free/busy from both Microsoft Outlook 2016 on a desktop computer as well as the Outlook app on a mobile device.

• The Test.User2@devfabnkam.com account has a mailbox that is hosted in the Exchange Online environment

• The AlexSimmons<sup>4</sup>fabnkam.com is hosted in Exchange Online. Alex reports Outlook 2016 issues. The client application starts up and connects to his mailbox, but it will then crash after a few minutes.

• The mailbox named Lola.Jacobsen@fabrikam.com is hosted in Exchange Online. An Exchange Online mailbox database issue affected Lola and some other users in the human resources department. You need to troubleshoot client connectivity issues with Lola s mailbox

• The mailbox named Sarah.Jones@fabrikam com account is hosted in Exchange Online. Sarah reports that emails that she sends are not being received. You must inspect emails that Sarah has sent recently to investigate the issue.



The tenant is your Office 365 account, including hosted Exchange, Skype for Business, SharePoint, and your Office 365 Active Directory. The first account that you create when you first purchase Office 365 is the "owner" of your tenant. This account should be an admin account, not a person. This account does not normally require an Office 365 license. Relating to SharePoint, all of your site collections are within your tenant. You can have any number of domains within your tenant (with email accounts), but you will have only one root SharePoint URL:https://xxxx.sharepoint.com.

The Global Administrator account is similar to the Company administrator. Users in this role have access to everything or the permission to add them to a dedicated role where they do not have permission (such as discovery management and assigning administrative roles to other users).

When setting up Office 365 the first step is to purchase your subscription which includes choosing the plan. Step 2 involves the selection of the sign-on method and this is where the global administrator account is of consequence. Step 3 involves the collecting of information such as domain names and DNS, locations, etc...

Step4 is the actual migration plan and schedule, step 5 – the Microsoft account and organizational account, step 6 – the SkyDrive and SkyDrive Pro, and step 7 – the Windows Intune section.

Thus you should perform step 1 through 3 to ensure that all user accounts to make

use of a custom domain for their e-mail.

The Office 365 Mid-sized businesses and Enterprise plans will allow you to enable Litigation Hold. The Professional plan is not compliant with this setting. User mailboxes that are placed under litigation hold with the external audit enabled meet all compliance requirements, because the data is immutable.
